

**2. Main areas of responsibility :**

The main task of the unit "Control of traditional own resources and assistance to candidate countries" is the verification of Member State's compliance with Community requirements for the correct, complete and timely collection of traditional own resources (mainly customs duties collected by Member States' customs authorities) that are made available for financing the EU budget.

This post offers an excellent opportunity to become familiar with the EU's financing, and, in particular with the system of traditional own resources.

The national expert will take part in the unit's monitoring of Member States' action for the recovery of traditional own resources. The job includes the participation in the examination of individual cases, preparation of Commission positions and their administrative and financial follow-up, as well as the preparation of general analysis and reports on the recovery of traditional own resources. Moreover, s/he will also have the possibility to work in other areas of the unit, e.g. by assisting in the on-the-spot inspections to Member States and in the follow-up of the Court of Auditor's findings concerning traditional own resources. The job involves frequent contacts with other Commission services and Member States' representatives.

**3. Main qualifications :**

The candidate should have a university degree (preferably in law or finance), a solid work experience in the customs field with good knowledge of the Community customs procedures and provisions, and, preferably also some experience in debt recovery. The candidate should also have good interpersonal skills to support team working and s/he should like to work in an international, multicultural organisation. Excellent drafting skills are needed for the job.

The job involves the analysis of competition issues in the sector concerned as to their legal and economic merits. The tasks include in particular:

- \* contributing to the implementation of all procedural steps of case-specific investigations relating to Articles 101, 102 and 106 of the Treaty in the sectors within the Unit's competence. This involves individual work as well as a member of case teams, and regular contacts with companies and their legal representatives, contacts with other DG Competition Directorates and with other Commission services.
- \* contributing to the development of competition policy, for instance by participating in working groups and preparing reports.
- \* preparing briefings and speeches for the Commissioner and the Director-General responsible for competition policy;
- \* market monitoring in the sectors falling within the Unit's remit, with a view to detecting anticompetitive conducts and proposing possible ex-officio investigations.
- \* analysing and clarifying competition issues in the context of informal contacts with companies and their legal representatives, e.g. in the context of informal complaints

\* preparing replies to parliamentary questions and questions from undertakings and citizens relating to competition policy.

The case-handler will be primarily responsible for anti-trust cases, in particular cartels and cases of abuse of a dominant position. The work may also involve merger case-handling in the same sectors (falling within the responsibilities of unit E4).

**3. Main qualifications :**

Legal and/or economic background in the area of competition policy, gained either through university studies or through professional experience. Relevant experience in the Consumer goods, Basic Industries, Agriculture and Manufacturing would be welcome.

In close collaboration with the rest of the forest team, the SNE will play an important role taking forward this work. Responsibilities will include:

- i. Coordinate work with Member States and liaise with Council to implement the FLEGT Action Plan;
- ii. Support the development of voluntary FLEGT partnership agreements (VPA) with developing countries;

#### *Forests and climate change (REDD+)*

Reducing emissions from deforestation and forest degradation is a global priority of the EU framed by the on-going climate talks. While the DG in charge of climate action leads in negotiations for the European Commission, DEVCO provides the interface to development policy and priorities. The C-2 Unit supports this initiative, and aims to ensure that developing countries have the capacity to access the opportunities afforded by REDD+ in implementing their sustainable development strategies. In close collaboration with the rest of the forest team, the SNE will play a key role taking forward this work. Responsibilities will include:

- i. Coordinate work with Member States and liaise with Council on the development of policies that encourage forested developing countries to benefit from programmes that reduce in emissions from deforestation and forest degradation (REDD+);
- ii. Promote the development of effective coordination between FLEGT and REDD+ initiatives in VPA partner countries;
- iii. Advise on the design of development assistance to support implementation REDD+ initiatives in developing countries.
- iv. Provide advice and guidance in the steering of multilateral initiatives that have been established to pilot and test REDD+ approaches and programmes.

#### *Programming of EC Development Co-operation*

- i. Provide expert advice and input into the programming of European Commission country and regional development assistance focused on natural resources;
- ii. Provide advice and guidance in programming and back-stopping of selected policy-oriented projects funded under EU global programmes supporting European Commission work on FLEGT, Forests and REDD+;
- iii. Provide guidance and steering to European Commission supported multi-donor initiatives on FLEGT and REDD+, including through participation to steering committees of key EU funded projects.
- iv. Contribute to evaluation and lessons learning from EC funded projects on FLEGT and REDD+, to feed in policy development and programming.

### **3. Main qualifications :**

The candidate will hold a university degree in natural resource management, economics or a related field. Specific skills and experience required for this post include: good knowledge of forest governance and natural resources management, a strong sense of initiative, capacity to think and act strategically, networking and team building capacity, and good negotiating skills. ### 2. Main areas of responsibility :

As the central coordination and policy strategy unit of the Directorate-General, our mission is to strengthen policy coordination, including the inter-institutional dimension, and develop coordinated policy strategies. The unit's main areas of activity include the coordination and policy strategy for the integrated surveillance of the EU economy and the Member States; EU 2020 strategy; as well as the economic policy strategy for the euro area, including in relation to other international institutions (i.e. OECD, IMF). The unit contributes to strategic planning and programming by developing proposals for the work programmes of the Directorate-General and of the Commission. Inside the Directorate-General and in the context of economic and financial policy making, the unit develops contacts, coordinates and monitors the relations with other EU institutions, in particular the European Parliament, the Council, their Committees and the Council Presidency. The central role of the unit offers an excellent opportunity to the seconded national expert to contribute to the development of strategy in the area of economic and financial policy, particularly in the euro area.

The seconded national expert will play a major role in the unit's analytical and policy-development. S/he will be a key player in the team which, on the basis of robust economic analysis, will develop the Commission's economic orientations for the annual cycle of surveillance, and will follow-up those orientations with work particularly focused on deriving operational policy and strategic recommendations from the available analysis. Such follow-up will also include work on the monitoring of the implementation of policy recommendations and on the assessment of the impact and spillover effects of major economic policy reforms. This work will require close cooperation with other colleagues across the Directorate-General and with other Commission services. The seconded national expert may also be called upon to contribute to work in other aspects of the unit's responsibilities.

### 3. Main qualifications :

The seconded national expert should be a highly-qualified macroeconomist with, ideally, at least 8 years of post-graduation work experience in a Central Bank, Ministry of Finance or Ministry of Economic Affairs working on macroeconomic and fiscal policy issues, including both economic analysis and the development of economic policy.
